Grant Application Rules & Guidance Notes

- 1. These rules & guidance notes should be read in conjunction with the Village Project Grant Application Form.**
- 2. If the application is received prior to the closing time and date of 5pm on Monday 30th September 2024, it will be accepted for consideration by the Parish Council.**
- 3. The Application will only be considered from individuals or organisations that reside or operate within the boundaries of the Parish of Market Lavington and that can demonstrate a community benefit within the Parish.**
- 4. The application form must be fully completed, dated and signed by the applicant or person authorised to do so, giving as much information as possible.**
- 5. The decision to offer funding will be based solely upon the information contained in the application form, continuation sheets and any other written and photographic material that the applicant considers will support the application.**
- 6. Lobbying of Councillors and/or Panel Members will disqualify the application.**
- 7. The application must detail the exact nature of the works, equipment or support required.**
- 8. The application must demonstrate how the works, equipment or support will benefit the residents of the Parish of Market Lavington.**
- 9. The application must be fully costed.**
- 10. The application must have a start date and completion date for works, an expected purchase date for equipment and start date for support. Any money awarded must be spent for the declared purpose only and before 1st July 2025.**
- 11. Subject to 2 above, the application will be considered at the meeting of the Parish Council on Tuesday 15th October 2024 at 19:15 hrs in the Old School, Church Street, Market Lavington. The Parish Council's decision is final.**
